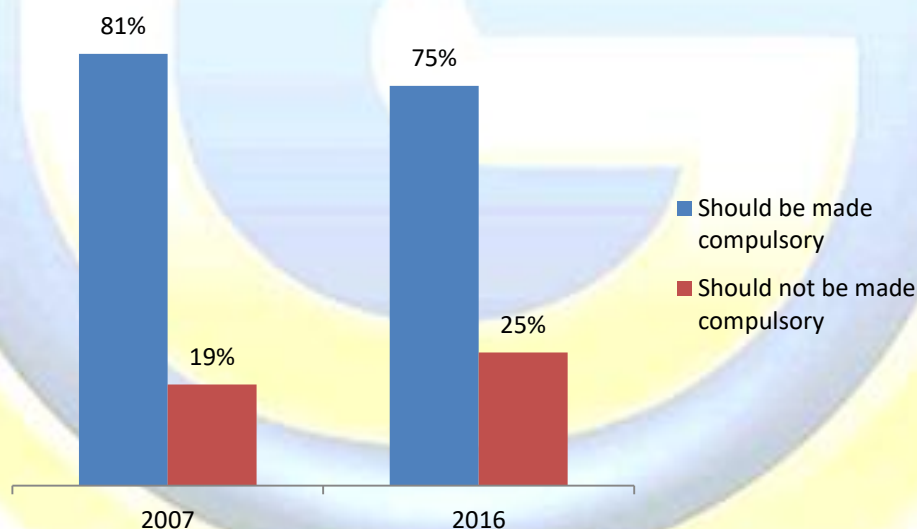
According to a Gallup Pakistan National Survey conducted in the year 2007 (9 years ago) respondents were asked, "Some people think that hijab should be made compulsory for all Muslim women, while others think there should be no compulsion. What is your opinion on this?" To this, 81% said it should be made compulsory for all Muslim women, 19% said it should not be made compulsory.

Comparative Picture: The question was asked again in 2016 to enable a concrete comparison. In 2016, 75% said it should be made compulsory for all Muslim women, 25% said it should not be made compulsory.

According to public opinion, there has been a 6% decrease in the proportion of people who want to make hijab compulsory for all Muslim women.

This press release has been made as part of the Gallup Pakistan History Project which aims to release historical empirical polling data to wider audiences. The objective is to sustain and encourage empirical decision making in Pakistan.
