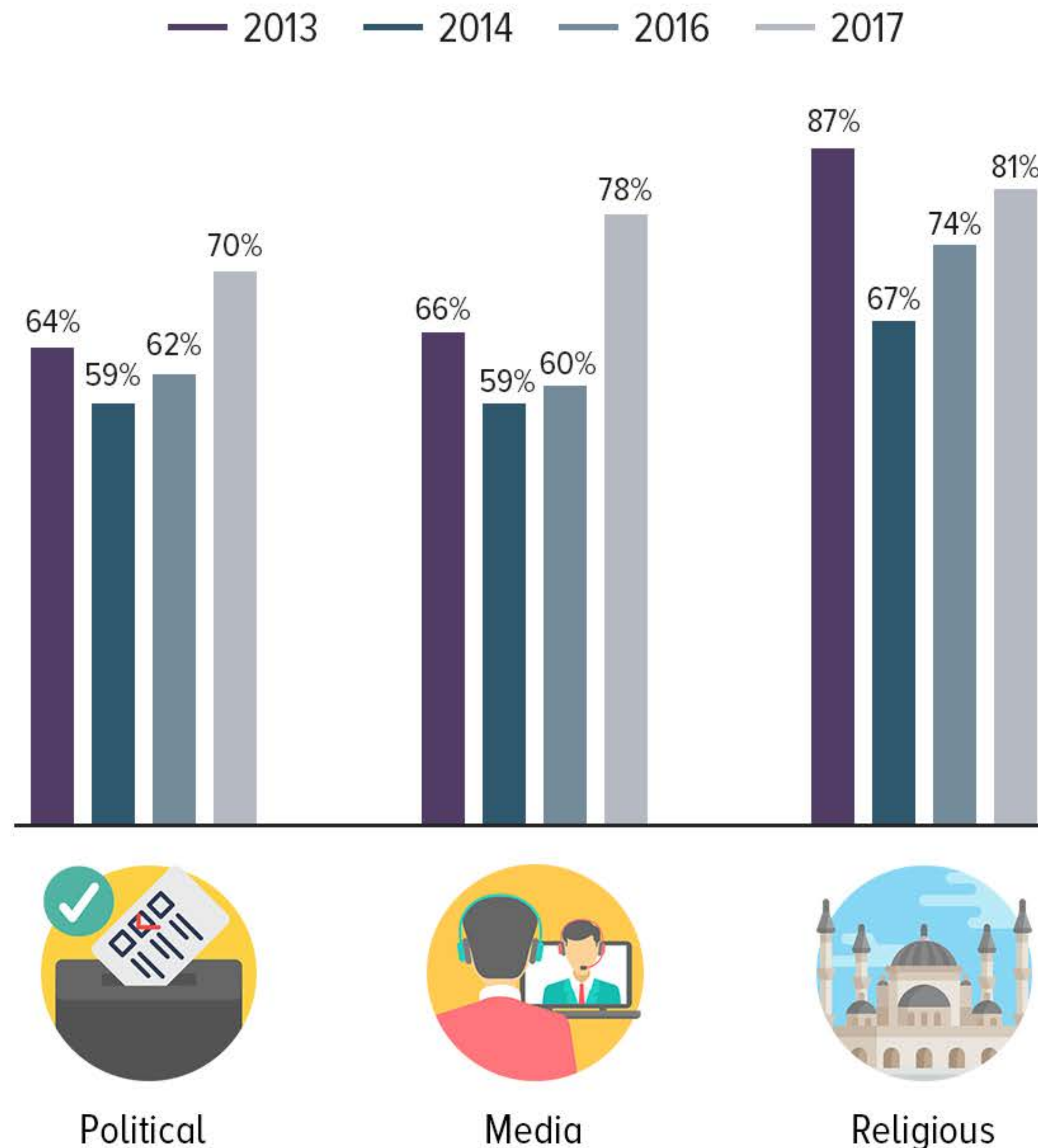

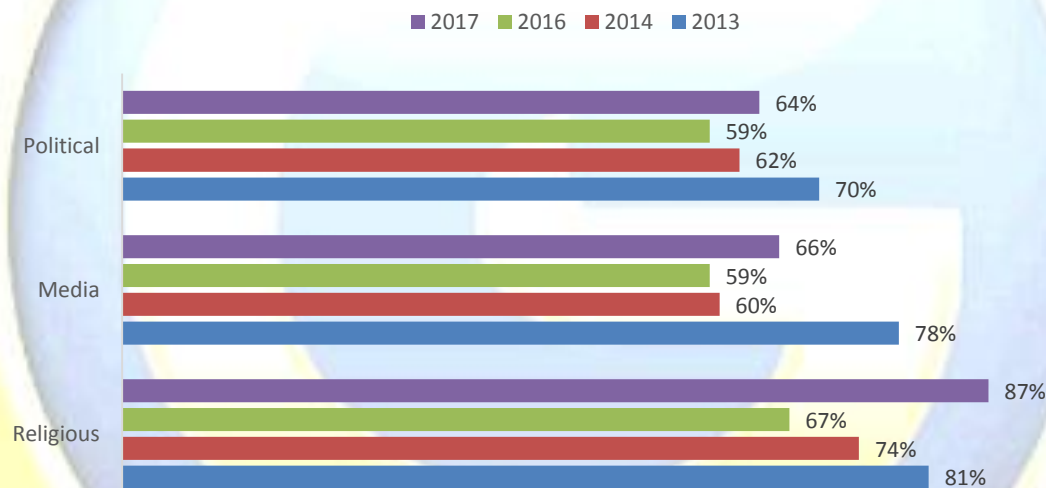

**2013-2017: More than half urban Pakistanis have favorable perceptions regarding religious, political and media freedom in the country.
(World Justice Project and Gallup Pakistan)**

Islamabad, August 7, 2018

According to the findings of the World Justice Project Report on *The Rule of Law in Pakistan* based on a Gallup Survey in urban Pakistan, more than half Pakistanis opine that they have religious (87%), media (66%) and political (64%) freedoms in Pakistan. It is also worth noting that the statistics for religious freedom relative to 2016 has increased by a considerable amount (20%). Meanwhile, the statistics for political and media freedom has increased since the past year by 5% and 6% respectively.

Average of Fundamental Freedoms in Pakistan: decline observed in political and media freedom, while increase observed in religious freedom during PML-N's tenure as the government of Pakistan.

Over the years, the greatest decline can be observed for media freedom (12%), followed by political freedom which decreased by 6%. Since 2013, religious freedom has increased by 6%.

In Pakistan, the survey was conducted between May and September in 2017 through face-to-face interviews in 2,010 households distributed proportionally across the five urban areas of Faisalabad, Karachi, Lahore, Peshawar, and Quetta.
