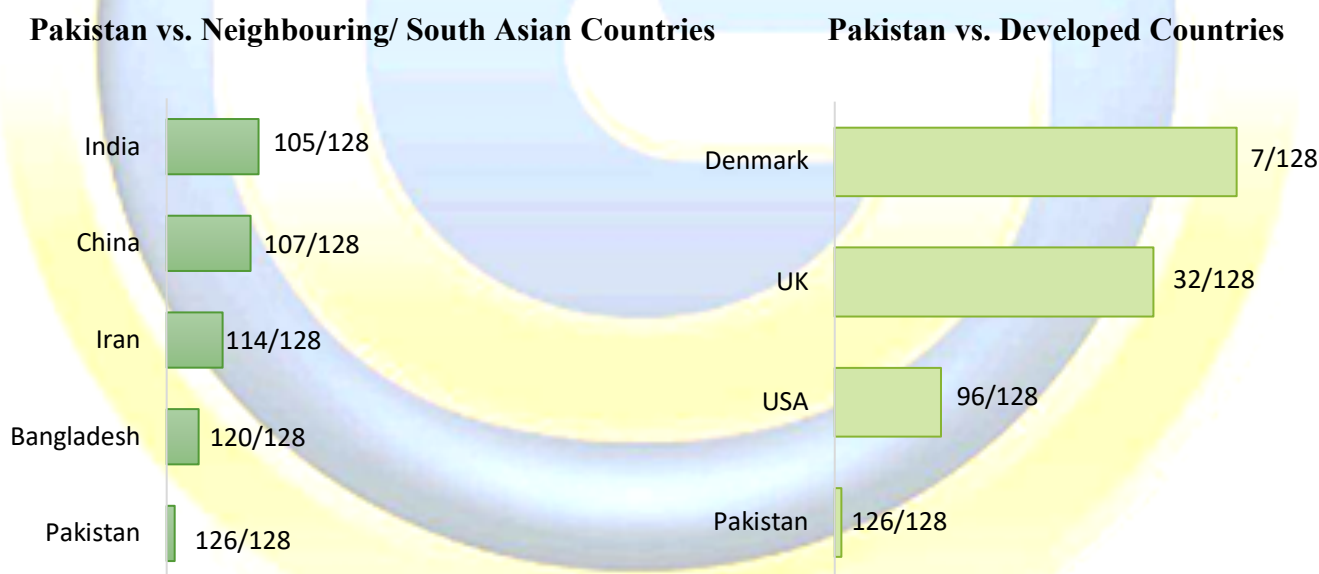

According to a World Justice Project (WJP) Survey conducted by Gallup Pakistan, Pakistan ranks 126 among 128 countries surveyed in the world on equal treatment and absence of discrimination.

The global survey results are based on sub-Factor 4.1 of the WJP Fundamental Rights Index which measures whether individuals are free from discrimination— based on socio-economic status, gender, ethnicity, religion, national origin, sexual orientation, or gender identity—with respect to public services, employment, court proceedings, and the justice system.

Pakistan vs. Neighbouring/ South Asian Countries: On this index, Pakistan ranks lowest, with India at 105, China at 107, Iran at 114 and Bangladesh at 120.

Pakistan vs. Developed Countries: Denmark ranks 7th on this index, followed by UK at 32 and USA at 96

The study was released by World Justice Project and carried out by Gallup & Gilani Pakistan, the Pakistani affiliate of Gallup International. The country scores and rankings presented in this report are built from more than 500 variables drawn from the assessments of more than 130,000 households and 4,000 legal practitioners and experts in 128 countries and jurisdictions. The study in Pakistan was carried out among a sample of 1,000 men and women in urban and rural areas of all four provinces of the country, during 2019. The error margin is estimated to be approximately $\pm 2-3$ percent at the 95% confidence level.
